For many years I have been trying to get the City of San Diego to provide meaningful oversight of the Torrey Pines Gliderport concessionaire for the purposes of fairness and safety. I have a long track record of those efforts.

I am continuing to pursue that goal, and my greatest concern about participating as an expert witness - in any one case - is that it may impede my ability to negotiate with the City to do a better job of oversight in general ... and for all cases.

Our office is currently investigating a potential case involving an in-air collision between two pilots at the Torrey Pines Gliderport. In doing research on potential consultants and experts in the field we came across your contact information.

The long and short of it is that our client, Shannon Hamby, was a student pilot and was being directed into the landing zone when another much more experienced pilot came in from above and negligently, recklessly and/or intentionally collided with her causing devastating injuries.
